<input type="checkbox"/>	At the age 13 or older, I was placed in foster care or was taken from my parents by the state and am considered a ward of the court.	Copies of appropriate court decree or official letter from social worker.
<input type="checkbox"/>	As of the date I filed the FAFSA, I am or was an emancipated minor before I became an adult.	Copies of appropriate court decree documenting emancipation and verifying effective through age of becoming an adult.
<input type="checkbox"/>	As of the date I filed the FAFSA, I am or was in legal guardianship (whereby a guardian was appointed for me) before I became an adult.	Copies of appropriate court decree (i.e. "Letters of Guardianship") documenting permanent appointment of a guardian and verifying effective through age of becoming an adult.
