Course Description:

This is the first of two field education courses that entails practicing in a human service agency under the guidance of an agency social worker and a faculty member. Field placement forms an integral part of the preparation of students for professional responsibilities in social work and serves as the integration of coursework into actual practice. All placements begin with an in-depth orientation to the specific agency setting. Students develop a working knowledge of the agency's functions, structure, processes, and its service provider role within the community. Students apply knowledge and develop skills in conducting interviews, problem identification, data collection, problem assessment, and goal formulation with the client systems in the context of social work values and ethics. Students integrate self-awareness and appreciation of diversity into professional practice. The foundation MSW field experience emphasizes generalist social work practice at the micro, mezzo, and macro levels.

Prerequisites:

Concurrent enrollment in SW 6610 is required. This course is graded credit/no credit.

11. Use supervision appropriate to generalist social work perspective to integrate classroom knowledge into practice skills in the field
12. Function within the structure of organizations and demonstrate an understanding of how agency mission, operational policy and procedures, resources, organizational structure and funding impact upon the delivery of social services
13. Establish, maintain, and manage effective helping relationships using appropriate problem-solving methods and demonstrating the professional use of self
14. Practice within the inter-professional environment of health and human services and demonstrate an awareness of community resources and an ability to appropriately utilize these resources on behalf of clients.
