The federal government through Code of Federal Regulations Title 2: Grants and Agreements Part 200 Uniform Administrative Requirements, Cost Principles, and Audit Reuirements for Federal Awards (2CFR Part 200) *establishes principles for determining costs applicable to grants, contracts, and other agreements with educational institutions*, as well as proper documentation required.
