

## Aon Hewitt WMU Job Evaluation Meeting Schedule and Recommended Attendees

**Aon Hewitt Assumptions:**

- Job evaluation is a high-level executive exercise.
- Aon Hewitt will actively facilitate the process as this is our area of expertise. When needed, Aon Hewitt and/or Warren Hills will serve as a “tie breaker.”
- In general, attendees should be executives. Directors (staff compensation system) will attend on a limited, exception basis as subject matter experts.
- No employee, including directors serving as subject matter experts will be involved in the evaluation of their own position.
- Additional attendees should be approved by Warren Hills in advance of the meetings.
- Project Team member Amy Brimmer to attend all meetings. Director HR Services and HR Representatives and will attend meetings involving their assigned departments.
- The meeting order matters. We have planned the order based on several considerations including number of benchmarked positions and other anchor positions.
- Office Administrative (administrative support) positions will be placed by Aon Hewitt according to an office administrative matrix. Placements will be reviewed in vice-presidential meetings.
- Marketing and communications positions will be placed by Aon Hewitt according to the marketing and communications matrix. Placements will be reviewed in vice-presidential meetings.
- Decentralized Information Technology positions will be placed by Aon Hewitt and reviewed initially by Academic Affairs. Placements will be reviewed in subsequent vice-presidential meetings.
