Program will leave students three courses away from completing a master's degree. Three undergraduate courses will be offered and recommended to students looking to pursue secondary teacher education. ES 5200 being renamed from currently-existing course. TEL 5150 will be recommended but not required. Program will draw from WMU undergraduates, as well as those who have completed bachelor's degrees at other institutions.
