THE PROGRAM AND TRACKS

The program requires an interdisciplinary coursework of 33 credit hours focused on core theoretical concepts, analytical skills, and professional communication. It also allows you to choose between a capstone exercise and an internship and between public and nonprofit administration tracks depending on your interest and desired careers. This major can be pursued either as the only major or as a second major if your major falls in content areas that can apply to public and nonprofit sectors.

Public Administration Track: Choose this concentration if you are interested in entry to mid-level careers in administration, analysis, or management across the vast public sector at the federal, state, county, and local governments. This track involves coursework in public management, public budgeting and accounting, and a multitude of elective courses such as community growth and development, social policy administration, international financial management, and culture, diversity, & social equity. With advisor approval, you can also combine elective courses from other departments.

Nonprofit Administration Track: Choose this track if you are interested in entry to mid-level careers at charitable organizations, foundations, or nonprofit management or organizing focusing on arts and culture, community development, education, environment, health care, social services, and event planning. This track involves course-work in nonprofit management, nonprofit budgeting and accounting, and a multitude of elective courses such as fundraising, grant writing, and social entrepreneurship & innovation. With advisor approval, you can also combine elective courses from other departments.

Minors: The program also offers respective minors in public and nonprofit administration. Designed for those majoring in content areas that are broadly applicable to the public and nonprofit sectors, these 18-credit hour minors can be used to strategically prepare for a variety of administrative and managerial functions of programs, policies, or organizations.

Accelerated Graduate Degree Option
