In the 2016-17 academic year, IE began routinely categorizing sexual misconduct allegations after staff reviewed the reported behavior, instead of how the reporting party labeled the behavior. This resulted in more cases being added to the “consultation” category and less cases reported under sexual harassment. Most of the consultations were regarding behavior that involved some form of a broader definition of harassment, but did not meet the definition of sexual harassment as defined in the Policy. If, as reported, the behavior clearly had no sex/gender basis, nor discriminatory effect, the incidents were referred to the appropriate office for review and response. The pattern of these cases indicate that administrators, faculty, staff and students need University-provided training and development on supervision, resolving conflict, bullying prevention and appropriate workplace/classroom conduct.

On August 14, 2020, WMU implemented a revised Sexual and Gender-Based Misconduct Policy. Key changes relevant to this report include:

- The definition of gender-based harassment was separated from the definition of sexual harassment.
- Sexual assault was changed to non-consensual sexual intercourse.
- Per the 2020 Title IX Regulations, the outcome “informal resolution” may only be applied to cases where a formal complaint was signed by the Complainant. Therefore, cases resolved prior to a signed formal complaint are now deemed “resolved during assessment”. The requested resolution may include supportive measures such as a no contact order or accommodations for course work.
