CEHD 1022 HPHE New Major: Event Management Major

Discussion: Number 1: should only say "this is a creation of a new major". The first paragraph can go into the rational section. Question 2: Leave out sentence about stand-alone major. Add HPHE 3300 to Core classes listed. Remove HPHE 2200 from core classes. Remove section about core classes all together in question 2.

Question 3: take out the core classes. Fix language. Question 4: remove last sentence. Take out three majors. "The collaborative nature of the combine majors, using their collaborative nature..." There will not be scheduled conflicts. Remove last paragraph. Question 5: Fix "Sport Management Major" (not "Sports Management"). Add "See attached letter of support from CEHD Dean" when referring to faculty needed. Remove paragraph about influx of students and paragraph starting with "In summery". Question 6: The part about industry partners should go in section 8, but is fine in question 6.

Question 8: change wording in fourth sentence... say "creating major" and take out last sentence starting with "however". Add "(see letters of support in appendix)".

Question 9: Second paragraph: remove first two paragraphs, and last sentence "please refer to..." Work with the advising office and refer to advising information sheet.

Question 10: It should say proposed catalog copy and delete paragraph. Remove 'please see appendix' and remove from table of context.

Remove minor classes from catalog copy. Related electives should have the word "cognates: related electives" included. In related electives there's a type that should be MGMT as opposed to MTMT. If it does not require a minor that needs to be in the catalog (leave it as is). Catalog copy: base salary statistics should be removed, otherwise the statistics will have to be updated every year. Eliminate all the "pending approval from...".

Discussion: The last three classes (page 372) have pre-reqs of FCS 1560 1570 and 1590, but 1590 is not required. 2500 could be removed. Another class can't be added, there are already a lot of classes in this minor. Drop course FCS 2420 Design History - it should clear up the pre-reqs. The minor will be 18 credit hours. Question 1: change to "revise the interior design minor". Rational: courses have been revised.
