This course is a follow up to an existing course, FCS 3530 Intro to Interior Construction I. The material covered will expand into this course to cover more understanding and application of the material presented in the first course.

The application of the codes, construction standards and systems technologies require more instruction through application to an interior design project.

In 2017, our program was re-accredited by CIDA (Council for Interior Design Accreditation). The site visit was preceded by a self-study of our program by the faculty. In the self-study, many CIDA standards were successfully addressed in the design process but were lacking in some areas in their final documentation. Review of construction documents were acceptable by CIDA standards but showed areas of improvement in the self-study.

Input from the Professional Advisory Board suggests that students need to strengthen their to convey design knowledge and application of construction in order to be more confident and competent of their design intentions. This was also evident in the mock interviews which are conducted in the FCS 4520 Professional Practices course (formerly FCS 3520).
