Action Items

Ila Baker, Center for English Language and Culture for International Students, and John Saillant, English, were re-appointed to the Library Committee.

Discussion Items

7 October Senate Meeting

Members reviewed the previous night's Senate meeting. Cooley commented that the banquet rooms of the Fetzer Center provide a better location to hold Senate meetings than the large auditorium does. Lagerwey suggested James S. Thomas, Western Michigan University's new vice president for development and alumni relations, be invited to speak at the November Senate meeting.

Budget Forum and Additional Updates – Peter Krawutschke

Krawutschke, Jellies, and Lagerwey attended the budget forum the Senate cosponsored with the WMU-AAUP. Former Senate Vice President Dennis Simpson attended and spoke at the invitation of the Board. The forum was well attended and the Board appreciated Sociology professor Ronald Kramer's closing remarks about the value and importance of education beyond economics.

Council Reports from Liaisons

International Education Council – Lagerwey reported members discussed the charges issued to the council by the Senate's Executive Board and concerns arising from how credit for independent study is given by the Haenicke Institute. The Board suggested

the credit issues might be referred to the new Transfer of Credit Committee for review.

Committee on Extended University Programs – Cooley reported the committee's chair, Barbara Barton, Social Work, was committed to faculty control of the curriculum for online courses. E-Learning standards were presented to the committee.

Professional Concerns Committee – Rypma reported the committee has a new chair, Rob Eversole, Biological Sciences, and was looking forward to the provost's visit at its next meeting to discuss the status of its pending memoranda of action with him.

Graduate Studies Council – Rantz reported the council has a new chair, Louann Bierlein Palmer, Educational Leadership, Research and Technology. The council approved a new degree - Master of Science in Engineering (Chemical) - in the department of Paper Engineering, Chemical Engineering, and Imaging and Eileen Evans reported on the upcoming visit from the Higher Learning Commission. Next month the council will review the report prepared by the committee the provost formed to study the graduate college.
