# WESTERN MICHIGAN UNIVERSITY FACULTY SENATE EXECUTIVE BOARD MINUTES OF 22 April 2011

**Members present:** Osama Abudayyeh, Van Cooley, John Jellies, Peter Krawutschke, Mary Lagerwey, William Rantz, and Delores Walcott. **Member absent:** Judith Rypma. **Guest:** Dan Litynski, Vice President for Research. **Also present:** Janice Anderson, Faculty Senate Office.

The meeting was called to order at 11 a.m.

## Dan Litynski, Vice President for Research

Krawutschke welcomed Dan Litynski and introductions were made. Litynski was invited to discuss the status of the Office of the Vice President for Research and the resources and handicaps toward achieving the university's research goals. He gave a PowerPoint presentation, provided and reviewed a packet of materials, followed by a very thorough conversation with the Board. Thirteen positions in his office have experienced personnel changes during the last 18 months. A new electronic buck sheet is now in place that might be commercialized for use at other universities. Litynski sees campus centers a way to increase and encourage research opportunities and, as a goal, would like to be able to provide five year funding to centers. Current fiscal challenges were acknowledged and recognized by all. Two outside organizations have been hired to assist his office in locating external funding for faculty. One upcoming initiative is to review the OVPR policies and procedures which will be done through the Senate's Research Policies Council. Litvnski also mentioned the grant application of Senate Board Director Cooley which is a 7 million dollar proposal for job core training which would be implemented through cooperation of the College of Education and Human Development and Extended University Programs if funded.

Board members shared faculty concerns with Litynski which he took note of:

- There is no recognition of research submissions that are unsuccessful.
   OVPR might follow up with those faculty to suggest ways to improve their chances for receiving grants.
- Assist in dispelling myth that there is no funding available in some research areas.
- Provide more encouragement to faculty seeking small grants.
- Especially with faculty workloads increasing, it would be very helpful to remove existing impediments by providing principle investigators with sources for technical support and a list of available grant writers.

Members thanked Litynski for attending and having a lengthy discussion with them. He left the meeting at 12:10 p.m.

#### Position Paper

As both have been now discussed outside of executive session by the Board, it was agreed Krawutschke would reference the 2 July 2009 letter and the Shared Notions on Program Consolidation and Elimination at the 5 May Senate meeting. President John Dunn would be notified in advance so he could be prepared to respond if need be. The intent is to inform Senators that should review of programmatic concerns arise; the current Senate Executive Board will support and adhere to the process approved by the previous Executive Board in July 2009. This action was moved and seconded. Motion carried.

## 5 May Senate Agenda

This is to follow the usual agenda for the May meeting which consists of two sessions which close out the 2010-11 Senate and then open the 2011-12 Senate. There are no changes in the Senate president or board members this year but council elections will be held. Other than procedural items, President Dunn has confirmed his attendance and Provost Tim Greene will be invited and asked to provide an update on the University Strategic Plan. The one information/discussion item will be a report on the American Council on Education Internationalization Laboratory Report by Maira Bundza, chair of the International Education Council. Approval of this agenda was moved and seconded. Motion carried.

#### Committee Nominations

Approval of the nominees for Senate and University committees provided by the Senate's Nominations and Elections Committee was moved by Rantz, seconded by Jellies. Motion carried.
