## CURRENT POLICY WITH REVISIONS IN BOLD AND DELETIONS WITH STRIKETHROUGH

- C. Award Conditions:
  - 6. Awardees are required to submit an proposal(s) to a funding source(s) external funding proposal to the University to support their scholarly activity, processed through the University's proposal approval (i.e. Proposal Approval Form) and award management systems, for an amount at least equal to their FRACAA grant within 18 months of the end of their award period. An external funding proposal is defined as one submitted via the OVPR proposal management center with an approved Proposal Approval Form.

## Official Memorandum of Action – MOA-16/02 Revised Faculty Research and Creative Activities Awards Guideline C6

## **Background**

Established via MOA-08/03, the purpose of the FRACAA program is "to increase external funding at WMU." The program guidelines require recipients to submit an external funding proposal for an amount at least equal to their award within 18 months of the end of their project period.

This requirement is documented by records kept of external funding proposals approved through WMU's Proposal Management Center via a Proposal Approval Form. All grant and contract proposals submitted by WMU faculty and staff on behalf of and approved by WMU are processed through this system. Proposals submitted by faculty and staff that will flow directly to the individual, not through nor managed by WMU, are not processed through this system, are not considered external funding, are not reported to WMU's Board of Trustees or external agencies as external funding, and are not accepted to satisfy the FRACAA requirement for submission of an external funding proposal.

Some faculty and staff at WMU believe that the external funding proposal requirement as it exists currently limits their access to FRACAA funding because of perceived limitations of external funding opportunities associated with various disciplines. They assert that in some fields, prestigious awards are made directly to the individual as fellowships and stipends – funding mechanisms where awards do not flow through the university's pre-and post-award systems.
