Develop Proposal Criteria

The committee completed its review of the draft criteria and categorized these according to Criteria for Evaluating New Proposals, Annual Review Criteria, and Five-Year Review Criteria. Discussion was held regarding subsequent use of the criteria and if it would be used to eliminate a Center or Institute. Some members suggested that the review criteria could be used in a process similar to the program review process, but applied to C&I's. Although it's uncertain how the criteria will be interpreted and used to make decisions about C&I's, only University Centers and Institutes will be reviewed by the committee.

## OTHER

A question was raised regarding faculty with joint appointments, and where they should be reporting their activities. It is unclear if faculty credit for activities should be reported in a department or in a C&I.

The committee charges includes reviewing proposals for new C&I's and providing recommendations to the Faculty Senate Executive Board, it was decided that the committee would need to review a pending proposal. The proposal from CAS for an Institute for Intercultural and Anthropological Studies (IIAS) is outstanding for review. This proposal will be reviewed at the next meeting using the criteria established to date.

Next steps were established as follows:

- 1. Review the three sets of criteria.
- 2. Review the CAS Institute for Intercultural and Anthropological Studies (IIAS) proposal.
