CAS Institute for Intercultural and Anthropological Studies Proposal Several issues were raised as the proposal was being reviewed, including:

- Since the courses will be taught by faculty housed in other units, is there support from the other units to contribute faculty, and will the faculty have joint appointments?
- Have the faculty from the dissolved units been reassigned to other units?
- What issues, if any, do the receiving unit chairs see with these new assignments for the transferred faculty?
- As there is only a director and no assigned faculty?
- Who will be the members of the Institute?
- Will it be up to the director to appoint members to the Institute?
- Will the Institute be able to offer tenure to faculty?
- Will there be a problem if some of the faculty are not full professors?
- Have other organizational structures been considered, such as forming another department or school?

It was suggested that letters of support from other units should be included with the proposal. It was determined that College of Arts and Sciences Dean Carla Koretsky will be invited for further discussion at the next meeting.

A motion was made by Rudge, seconded by Ziebarth, to postpone the proposal until concerns are discussed with a CAS representative. Motion carried.

Review/Revise Criteria

The three sets of draft criteria, new proposals, annual review, and five-year review, were reviewed and finalized.
