## **Faculty Senate Oct. 1, 2020 Virtual Meeting**

### **Remarks from Faculty Senate President Marilyn Kritzman**

- At the last meeting the Senate took action on [MOA-20/07](#): *Revision to the Organizational Changes of Academic Units*, item 6 to invite faculty voice during discussion of recommendations regarding program reorganization and elimination. Additional questions were raised regarding item 4-inclusion of documentation; and item 7-review by the Senate. A complete review of the document reveals that item 4 is covered under items 7 and 8. Regarding item 7 all proposals are first vetted through each college curriculum committee, which fall within the purview of the college dean. It is hoped that full discussion occurs there. Please remember that any recommendation from the Senate is just that, a recommendation. All decisions rest with the administration.
- Faculty Senate staff member, Suzanne Davenport, was recognized for her 41 years of service in anticipation of her retirement on Oct. 31 2020.
