Call to Order

The regular meeting of the Western Michigan University Faculty Senate WMU Essential Studies Executive Advisory Committee was called to order at 1:05 p.m. on 10 November 2020, via Webex video conferencing by Jonathan Bush, chair.

Executive Boar Ex Officio Summy reported that Colleen Stano was elected as chiar of the WMU Essential Studies Course Review and Approval Committee. She noted that the suggested changes to MOA-20/04 at the last meeting have been implemented and that Provenzale has updated the forms to align with WMU Essential Studies terminology, however, corrections to Banner workflow will not be implemented until the Banner upgrade is completed two years from now. Provenzale added that the delay is due to lack of personnel.

Reports of Subcommittees

Due to the absence of the WMU Essential Studies Interim Director Cousins a report was not provided.

Hains did not provided a report of the WMU Essential Studies Course Review and Approval Committee.

Unfinished Business

Summy put forward MOA-20/04: Establishment of WMU Essential Studies Data Governance Policy with corrections from the previous meeting. It was questioned how aggregate data will be provided to faculty. Summy stated that it will be distributed by Student Learning Outcomes in course categories, with reports on levels achieved by percentages, but not at an individual instructor level. Discussion was held regarding including faculty in data reports to reassure faculty if there are concerns about how data will be used. It was suggested that an additional MOA be developed to specify the data delivery and data analysis. It was moved by Riggs, seconded by Hains, to approve MOA-20/04 to go before the Executive Board at its next meeting. With one against the motion carried.
