- **TWO FACTOR AUTHENTICATION IS COMING:** The Executive Board agreed to support the Academic and Information Technology Council's recommendation from the Office of Information Technology to require two factor authentication for all WMU employees
- **CIVILITY AT WMU:** To guide efforts and appreciate the meaning and practical applications of civil discourse and to strive to advance the Academy, the Faculty Senate approved a general aspirational statement related to civility.
