Riggs provided an update with revisions of the goals and objectives completed to improve measurability with the use of Bloom's Revised Taxonomy for curriculum proposal USC\_CFA52021\_Mus\_New Minor-JazzStudies.Fall2022. Rathbun noted a spelling error regarding statement #9, "pallet" versus "palette" which was corrected. It was moved by Riggs, and seconded by Slawinski, to approve proposal USC\_CFA52021\_Mus\_New Minor-JazzStudies.Fall2022. The motion carried unanimously.

Baker, Cork, Droppers, Edwards, Hearit, Klekar-Cunningham, Li, Yuanlong Liu, Rathbun, and Wagle were in attendance for discussion of curriculum proposal USC\_CEHD1155\_HPHE\_New-Major-EventMgt.Fall22. Discussion was held. Cork provided an overview of the proposal development. Questions were raised regarding academic outcomes, degree of rigor, potential conflict of interests, market research, learning outcomes, interdisciplinarity, program duplication, the use of courses in other programs, contextual importance, degree cohesiveness, collaboration, sharing of expertise to facilitate meaningful student degree paths, effects on enrollment, potential bias in advising, and the requirements of WMU Essential Studies courses. Slawinski suggested the proposal be postponed until revisions are made to the student learning outcomes and inclusion of Bloom's Revised Taxonomy. It was moved by Riggs, seconded by Ehrhardt, to postpone proposal USC\_CEHD1155\_HPHE\_New-Major-EventMgt.Fall22. With two abstentions the motion carried.

#### **New Business**

Weideman presented a summary of curriculum proposals GSC &USC\_CEHD1158\_New-ADP-ExerciseScience.Fall22, USC\_CEHD1181\_HPHE\_ChangeTitle-Minor-SportsCoaching.Fall22, and USC\_CEHD1183\_HPHE\_New-Minor-StrengthConditioning.Fall22, and addressed questions.

Curriculum proposals USC\_CEHD1180a\_SPLS\_ChangeTitle-Major-ElemEdPK-3.Fall22 and GSC&USC\_CAS21-22\_REL\_ChangeTitle-Master-CompartativeReligion.Fall22 were postponed to the next meeting.
