## **Library Research Support**

Dean Garrison presented information on collections in the libraries, especially in light of the decision to eliminate Web of Science. She replied to questions of council members. Web of Science cost \$200,000 a year while Scopus cost about \$78,000.

With no nominations the election was postponed. Arugaslan will solicit volunteers to serve as vice chair.

Candidates for Vice President of Research and Innovation are encouraged to apply. The first round of interviews are scheduled for late February.

Graduate College Dean Byrd-Jacobs reported that nominations for All University Teaching and Research Awards are being accepted through February. Writing circles are continuing with strong support from students. The graduate faculty status policy is being reviewed with a focus on making sure the criteria are stringent enough for all levels of graduate faculty status. Input on criteria is appreciated.

Dean Garrison addressed additional questions of the council since additional members had joined the meeting. Discussion was held regarding the merits of Scopus versus Web of Science and use of each by faculty.
