**WMU Essential Studies Executive Advisory Committee  
Minutes of 13 September 2022**

**Call to Order**

The regular meeting of the Western Michigan University Faculty Senate Western Michigan University Essential Studies Executive Advisory Board was called to order at 1:30 p.m. on 13 September 2022 via Webex video conferencing by Jonathan Bush, WMU Essential Studies Faculty Director.

**Acceptance of Agenda**

It was moved by DeChano-Cook, seconded by Jeffers, to accept the agenda as presented. The motion carried unanimously.

**Reports of University Representatives**

Witschi announced that Bush has been appointed as the new WMU Essential Studies Faculty Director.

Witschi confirmed that questions regarding the curriculum approval process should be directed to him.

WMU Essential Studies Faculty Director Bush and Senior Director, Academic Collaboration Ott, will be providing informative presentations about the WMU Essential Studies program to the Provost's Council,

the Chair's Council, and individual departments. Bush will share the PowerPoint presentation with the members of the WMU Essential Studies Executive Advisory Committee for review.

#### **Reports of Councils/Committees Standing Committee(s):**

Hains provided the WMU Essential Studies Course Approval and Review Committee report. The committee reviews and approves courses for WMU Essential Studies credit received from college curriculum committees and deans and forwards its recommendations to the administration. WMU Essential Studies Course Review and Approval Committee reviews all previously approved WMU Essential Studies courses as least once within a seven-year cycle as determined by the committee.

Ott has the role of collecting data for WMU Essential Studies assessment and will be interacting with community colleges on course credit transfer agreements. Ott will provide a report at each WMU Essential Studies Executive Advisory Committee meeting. Ott and Witschi are on the WMU Essential Studies Course Review and Approval Committee. The initial WMU Essential Studies Assessment Data Review and Troubleshooting Event was held in the spring 2022 semester. Future events will be held once a year in the fall semester for assessment data review and troubleshooting. Room 4010 in the College of Health and Human Services has been reserved for the next event on 9 December 2022.

Witschi discussed the WMU Essential Studies Course Review and Approval Committee review process. One third of all WMU Essential Studies courses are scheduled to be reviewed each year as part of the cyclic review process. Hains discussed how this review process has been a significant project for the WMU Essential Studies Course Review and Approval Committee. The course review process needs to be simplified to improve the efficiency and reduce the reviewer workload. There are approximately 392 WMU Essential Studies courses and there is a need for more people to serve on the WMU Essential Studies Course Review and Approval Committee.
