Unaffiliated Units Curriculum Committee Creation

RECOMMENDATION

Create a faculty-based curriculum committee to recommend, review, revise, and approve courses and curriculum for all units that are not affiliated with an academic college. Those include, but are not limited to, the Graduate College, the Lee Honors College, and the Merze Tate College-University Studies program.

RATIONALE/PURPOSE

With the elimination of the Faculty Senate Extended University Programs Council in 2020 inadvertently the council's charge to "act in place of faculty/department/unit regarding curricular changes of offerings, specifically the University Studies program" was not assumed or reassigned to a new process. With the June 2023 approval of MOA-23/01: Recommended Revisions of General Principles of Curriculum Change this oversight became apparent. This MOA reinstates a curriculum committee consisting of faculty representation from all academic colleges to fulfil that role.

PROPOSED POLICY LANGUAGE:

The Faculty Senate Unaffiliated Units Curriculum Committee, a standing committee of the Faculty Senate, will serve and function as a college curriculum committee to recommend, review, revise and approve courses and curriculum for all units that are not affiliated with an academic college, including, but not limited to, the Graduate College, the Lee Honors College, and the Merze Tate College-University Studies program.

POLICY DETAILS

The Unaffiliated Units Curriculum Committee shall be composed of at least 13 members including three advisory members: the Graduate College Dean (or their designee); the Lee Honors College Dean (or their designee); The Merze Tate College Dean (or their designee); nine faculty members elected by the Senate (one from each of the academic colleges, one from an unaffiliated unit, and one representative-at-large); and the Faculty Senate president (or executive board designee) as an ex officio member. Membership of the Unaffiliated Units Curriculum Committee shall be elected and serve according to the Faculty Senate Constitution Article VIII, Sec. 7.
