## **Explanatory notes**

### **Campus safety and operations**

***\$1,819,171 for quarter ending 12/31/20***

The campus safety and operations category is broken out as follows:

PPE – Includes expenses for faculty and staff PPE items such as masks, gloves, wipes, installing plastic barriers, etc. (\$26,973). *Some items were re-allocated to other areas resulting in a negative expense for the quarter in this account.*

Custodial - Includes expenses for additional personnel to increase cleaning frequency as well as increased cleaning supplies and equipment. \$814,023.

Sindicuse Health Center - Includes costs for implementing and administering enhanced COVID testing capability for the campus health center, including increased staffing. Also covers expenses for no cost testing for students and staff (subject to certain requirements). \$556,082.

Athletics – Costs for increased testing requirements for athletes, extra cleaning, etc. \$476,039.
