Explanatory notes

Campus safety and operations

\$1,174,450 for quarter ending 6/30/21

The campus safety and operations category is broken out as follows:

PPE – Includes expenses for faculty and staff PPE items such as masks, gloves, wipes, installing plastic barriers, etc. *\$78,842.*

Custodial - Includes expenses for additional personnel to increase cleaning frequency as well as increased cleaning supplies and equipment. *\$681,092.*

Sindicuse Health Center - Includes costs for implementing and administering enhanced COVID testing capability for the campus health center, including increased staffing. Also covers expenses for no cost testing for students and staff (subject to certain requirements). *\$161,804.*

Athletics – Costs for increased testing requirements for athletes, extra cleaning, etc. *\$252,712.*
