- SUBJECT: Round 2 Future Proud Michigan Educator Grow Your Own Staff Grants Now Open

The Michigan Department of Education (MDE) welcomes new applications for Round 2 of Future Proud Michigan Educator Grow Your Own (GYO) Staff programming grants. These grants support the staffing needs of intermediate school districts (ISDs) and local education agencies (LEAs), both traditional public school districts and public school academies (PSAs), with pathways for school employees wishing to seek initial certification or additional endorsements, in accordance with Michigan Compiled Law (MCL) 388.1627b (27b GYO) of the State School Aid Act. These grants support Goal 7 of Michigan's Top 10 Strategic Education Plan to increase the numbers of certified teachers in areas of shortage.

In May 2023, MDE announced that 80 school districts were awarded GYO staff grants for reimbursements of tuition and fees at approved Michigan educator preparation providers, with books, testing fees, travel for coursework, and substitute employee wages also marked for funding eligibility.

Additional federal funds remain available for Round 2 of competitive grants, with grant award announcements expected in November 2023. These grants help ensure that Michigan students have access to well-prepared teachers by providing funding for school employees to seek certification or additional endorsements.

The application is open through **September 6, 2023,** on the Grant Electronic Monitoring System/Michigan Administrative Review System (GEMS/MARS) for eligible applicants (ISDs and LEAs) to apply for funds to support new or existing GYO programs. The federal grant expenditure window remains the same as Round 1, to allow all GYO Staff grantees to reimburse eligible staff expenses incurred between October 1, 2021, and December 31, 2026.

- A recording of the "Frequently Asked Questions" webinar from July 25, 2023, that explains best practices for completing GYO Round 2 applications.
- Individual meetings with OEE GYO grant team members on an as-needed basis for more specific questions.
