The HPHE 1700 Intro to Rec/Sport Management is already a requirement of the minor and it does not need to be taken prior to taking HPHE 3100 to provide quality instruction. This will actually improve class scheduling for HPHE 3100 since that class is only offered in the spring.

The HPHE 1700 is still a required course within the minor and not making it a prerequisite requirement will make it easier for students to schedule their classes within the minor.

 HPHE 1700 is still a required class within the Event Management Minor. Eliminating HPHE 1700 as a prerequisite will actually allow for flexibility in taking HPHE 3100 enhancing the scheduling process.

 HPHE 3100 is only offered in the Spring, therefore flexibility in scheduling is an enhancement.

HPHE 3100 is the core event management class and student demand is strong. The elimination of the HPHE 1700 as a prerequisite will not impact the key learnings or the demand for HPHE 3100. The Event Management minor has good enrollment numbers and this change will not impact the student or external market demand. This is a prerequisite change only.
