ED 3141 will be a clinical course to allow students seeking certification in the birth-kindergarten grade band to experience multiple early childhood environments serving infants and toddlers and their families. No course currently exists that will promote application of infant and toddler learning and development content to children in learning environment.

This course is designed to fill a gap between current and proposed courses in a new birth-kindergarten grade band major in teacher certification based on new requirements mandated by the Michigan Department of Education. ED 3141 will follow as the clinical field experience to the learning and develop content of FCS 3140.

It provides an opportunity for students to discover and assesses the various settings in which infants and toddlers can thrive. High quality, developmentally appropriate, play based perspectives for providing foundation for future academic learning be discussed while students are completing clinical hours working with children 6 weeks through 36 months. This course is 1 credit of seminar and 2 credits of placement in an infant or toddler classroom, play group or family infant toddler program.
