- 1) Remove ES 3950 (School and Society) as a co-requisite for ED 4072 (Teaching 3-6: Social Studies 2), and make it a prerequisite instead.
- 2) Remove the other co-requisites for ED 4072.
- 3) Change the minimum grade for the pre-requisites from 'B' to 'C/B.'
- E. Rationale. Give your reason(s) for the proposed improvement. (If your proposal includes prerequisites, justify those, too.).
- 1) In the new Elementary Education program, which was approved by the CEHD Curriculum Committee in the fall of 2020, ES 3950 is scheduled to be taken the semester before ED 4072. Therefore, ES 3950 needs to be listed as a prerequisite for ED 4072 instead of a co-requisite. Without this change, the Advising Office will have to manually register all elementary students for ED 4072.
- 2) The original rationale for having co-requisites for ED 4072 was to enforce a cohort structure. We now believe that the pre-requisites alone will be sufficient to enforce a cohort structure. Eliminating the co-requisites will enable students who are retaking ED 4072 alone (without the co-requisites) to register themselves for the course without needing manual overrides from the Advising Office.
- 3) The minimum grade for the ED 4072 pre-requisites is currently listed as 'B,' whereas the minimum grade for the professional education courses in the elementary program is currently listed as 'C/B.' Rectifying this contradiction by making the minimum grade 'C/B' for the ED 4072 pre-requisites will eliminate the potential for confusion among students, faculty, and staff.

Not Applicable. We are not proposing a new course. We are simply removing the co-requisites so that students will be able to register themselves for ED 4072 (as opposed to needing the Advising Office to do it for them), adding ES 3950 as a prerequisite, and changing the minimum grade for prerequisites from 'B' to 'C/B.'

 The proposed curriculum change is not a response to student learning assessment outcomes. Instead, it is an effort to 'clean up' a few loose ends from a substantive change to the Elementary Education program that was approved by the CEHD Curriculum Committee in the fall of 2020. The Elementary Education program needed to be changed in order to comply with new state regulations regarding teacher certification.

No Effect. We are simply removing the co-requisites so that students will be able to register themselves for ED 4072 (as opposed to needing the Advising Office to do it for them), adding ES 3950 as a prerequisite, and changing the minimum grade for prerequisites from 'B' to 'C/B.'
