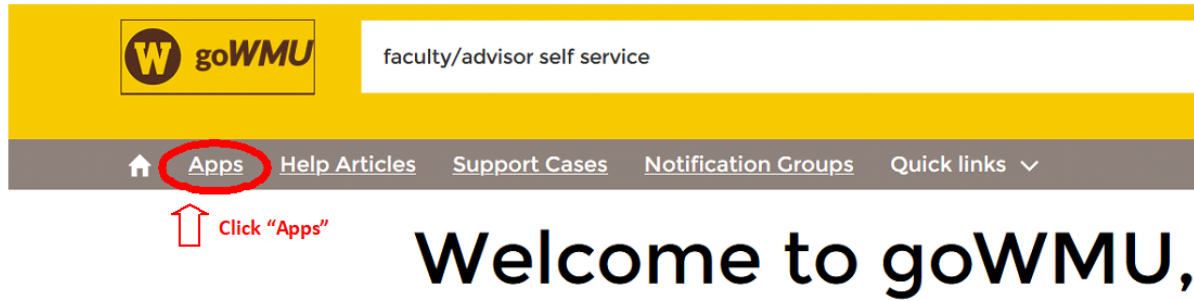

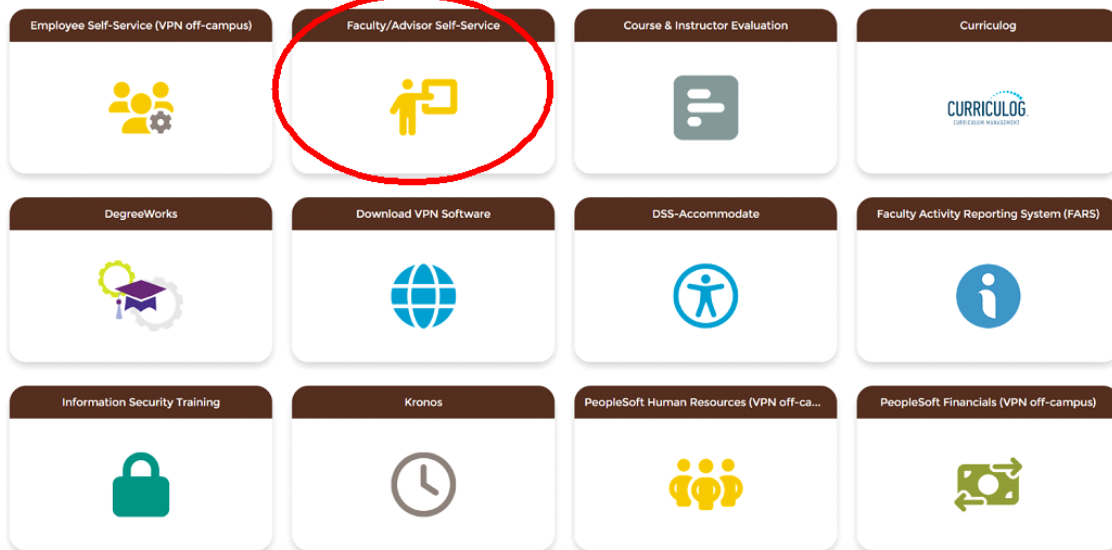
This tutorial will demonstrate how to complete and submit an Academic Dishonesty Charge Form.
