Members reviewed these eighteen course proposals. Several discrepancies in the areas requesting approval appeared in some of the proposals. However, members determined those were most likely due to the "cutting and pasting process" in preparing the proposals. As it was clear to the committee which areas the department was requesting approvals in, COGE agreed that shouldn't hold up approval.

Noting that three of the courses didn't include grading scales in their syllabi,

members approved them but requested the department chair be notified to inform the instructors of those courses of that oversight on their syllabi. COGE requested two general comments be included in the approval letter to the department chair:

- (1) The syllabi for all general education courses should address the general education area the course satisfies.
- (2) The assessment of learning outcomes is encouraged to further shape these approved courses.

Continuing Business

Due to time constraints, Fetters announced finalizing the course proposal evaluation form and subcommittee assignments would occur at the next meeting.
