# Intellectual Skills Program Advisory Committee Minutes of Tuesday, September 19, 2017

## PROCEDURAL ITEMS

Acceptance of the Agenda

Approval of the Minutes

A motion was made by Eisenhart to approve the minutes of Monday, May 1, 2017, seconded by Harvey (no corrections needed). Motion carried.

Duke reviewed the summer 2017 issues that arose with the new SAT scores being used for placement. Admissions only requires and records the SAT Evidence Based Reading and Writing and Math scores (no EBRW sub-scores). Scores are also no longer required to come directly to WMU from the testing agency. WMU now accepts scores noted on high school transcripts for admission decisions. A stop-gap measure that required hundreds of individual student records to be reviewed individually to ensure accurate placement was put into place. However, there is still concern that there may be students enrolled in ENGL 1000 who do not need it. There is no concern for LS 1040 due to students being allowed to self-direct reading placement.

The 2017 ISPAC year-end report was submitted to the Faculty Senate Executive Board. Faculty Senate President Suzan Ayers acknowledged ISPAC work at the year-end meeting held in May.

Committee Charges for 2017-18

The ten charges for the current year were reviewed. <u>Eisenhart made a motion to</u> accept the charges, Ballard seconded, and the motion carried.
