# RESEARCH POLICIES COUNCIL Minutes of 9 November 2017

The meeting was called to order at 2:36 p.m. by Council Chair Sue Steuer.

#### A. Procedural Items

1. Acceptance of the Agenda

Rowe moved to approve the agenda as proposed; DeFulio seconded. The motion carried.

2. Approval of Minutes of 12 October

### B. Discussion/Information Items

1. Research Policies Council/International Education Council Committee – Chris Coryn

There was no report.

- 2. Research Tools Subcommittee Muralidhar K. Ghantasala Ghantasala said that the sub-committee is almost assembled. Obare will join the first meeting and provide inventory on instrumentation from the Office of the Vice President for Research.

FRACAA groups are almost fully recruited. The new information ready system is working and Bertman has been working with OVPR to do some tweaking with the company.

#### C. Continued/Old Business

- 1. Old/New Research Policy Review Sherine Obare
- A. Policy on Eligibility as Pl/co-Pl on Grants for WMU

The revised draft was approved with additional definitions provided in this version.

- B. Intellectual Property Policy Memorandum Of Action
  Byrd-Jacobs moved, supported by Bertman, to approve the revised draft to move
  forward as an MOA to the Faculty Senate Executive Board. The motion carried.

- 2. Faculty Research and Creative Activities Award Utilization Analysis

  Descriptive Report Steve Bertman and Chris Coryn

  This award carries with it a condition requiring submission of an external grant for at least the amount awarded. The system for keeping track of whether this has been done is not smooth and does not require that the grant be for the same project, but only by the same PI. The study hoped to determine whether the program was resulting in more and stronger applications for external grants and this report is somewhat inconclusive. There is difficulty in knowing what data may be most meaningful.

There was discussion about the nature of grants in the humanities and fine arts. DeFulio offered to work with the numbers and see if he could tease out additional information.

3. Investigating Obstacles to Research – begin reviewing the Hanover Report – Sherine Obare

There is a need for more funding to support pursuit of grants. There was discussion about how to strengthen the culture for greater pursuit of grants for research. There were few surprises in this report.

#### D. New Business

- 1. Supporting Grant Applicants That Require Cost Share
  The practice of requesting cost share is inconsistent across campus. Some
  faculty go to their deans, others work with OVPR, others muddle through on their
  own. There was discussion of ways to inform grant seekers about appropriate
  routes (flow chart, instructions) to seek cost share in plenty of time to create a
  viable budget. This will be further explored by OVPR and guidelines will be
  presented for discussion in future meetings.
- 2. Support for Faculty Scholar Award Update
  Discussion was held about restriction on travel in the SFSA applications. Steuer
  will work with Melanie Greer in OVPR on language for the next round to clarify.
  There was discussion of open office hours for SFSA applicants.
